Hello all,

The DI team has some good news to share, with an announcement in that the submission/certification process, for the <u>DOL</u> <u>PY24Q3 PIRL Quarterly Report</u> has now been concluded, and that the PIRL data has been sent to DOL, the QPRs are now available, and our WPC <u>Department of Labor (DOL) reports</u> dashboards have been refreshed to reflect the new <u>DOL PY24Q3</u> <u>PIRL Quarterly Report</u>.

A. Updated Dashboards

- The data sets, for all of the WPC <u>DOL PIRL PM dashboards</u>, now have data for **PY24Q3**, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels, and at the <u>DOL Performance Measures (PMs)</u> level, all of which are defined, developed, maintained and produced, by DOL.
- 2) The data sets, for all of the WPC <u>DOL QRA dashboards</u>, now have data for **PY24Q3**, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels, and at the <u>Quarterly Reporting Analysis (QRAs)</u> level, all of which are defined, developed, maintained and produced, by DOL.
 - WA state does not currently receive <u>local</u> (LWDB/WDA) level data, from DOL, for the **DOL** Quarterly Reporting Analysis (QRAs) (aka, by DOL, as the PIRL Data Integrity (DI) reports), but our WPC <u>DOL QRA dashboards</u>, allow the data to be pulled at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels.
 - DOL Statutory citations, regarding WIOA sections, CFR subsections, TEGLs, and OMB control numbers, are identified, per each of our WPC <u>DOL QRA dashboards</u>.
- 3) The data sets, for the WPC <u>MSFW Monitor Advocate Status Report Dashboard</u>, now have data for PY24Q3, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels, and at the <u>MSFW Performance Measures</u> level, all of which are defined, developed, maintained and produced, by DOL.
 - WA state does not currently receive <u>local</u> (LWDB/WDA) level data, from DOL, for the <u>official</u> **DOL** MSFW Monitor Advocate Report, but our WPC <u>MSFW Monitor Advocate Status Report</u> <u>Dashboard</u>, allows the data to be pulled at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels.
- 4) The data sets, for the WPC <u>DOL TAADI dashboard</u>, now have data for **PY24Q3**, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels, and at the <u>TAADI Performance Measures</u> level, all of which are defined, developed, maintained and produced, by DOL.
 - WA state does not currently receive <u>local</u> (LWDB/WDA) level data, from DOL, for the <u>official</u> **DOL TAADI Report**, but our WPC <u>DOL TAADI dashboard</u>, allows the data to be pulled at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels.
- 5) The data sets, for the WPC <u>PIRL Exiters by Longevity</u>, now have data for PY24Q3, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels,
- 6) The data sets, for the WPC <u>PIRL Participants by Category (aka the PIRL "Slicer & Dicer")</u>, now have data for PY24Q3, at <u>both</u> the <u>statewide</u> and <u>local</u> (LWDB/WDA) levels.


B. Important Note

There was an <u>LWDB/WDA PIRL script incident fix</u>, of which was applied starting <u>PY23Q4</u> and going forward, of which <u>directly</u> affected the LWDB/WDA slicer, for all of our WPC <u>Department of Labor (DOL) reports</u> dashboards,

- 1) <u>LWDB/WDA PIRL Script Incident</u>: If a job seeker received services in multiple LWDBs/WDAs, the offices were not always put into the correct LWDB/WDA, for the performance measures.
 - The percentage of records that were affected by this PIRL script incident is very small.
 - Note: See the <u>November 12, 2024</u> Subject: WPC DOL Reports' Webpage Announcement -Enhancement of an LWDB Slicer general announcement, for more information, regarding how the LWDB slicer was implemented for the WPC <u>Department of Labor (DOL) reports</u> enhancement.
- 2) Keep in mind, that the recent <u>LWDB/WDA PIRL script incident fix</u> <u>did not and could not fix</u> the quarterly <u>historical</u> data sets, provided on all of our WPC <u>Department of Labor (DOL) reports</u> dashboards.
 - <u>Only the quarters going forward</u>, starting with <u>PY23Q4</u>, will reflect the recent <u>LWDB/WDA PIRL script</u> <u>incident fix</u>. (See example in Section B.3 below)
 - Those quarterly <u>historical</u> data sets <u>will still display</u> data by LWDB/WDA, <u>but</u> keep in mind <u>the</u> <u>LWDB/WDA PIRL script incident fix will not have been applied to those quarterly historical data sets</u>.
 - This is because WA state cannot refresh/resubmit a previous PIRL. Once a PIRL has been certified and reported/sent to DOL, its data stays the same, for the life of the specific PIRL.
 - This means, you may see offices that you don't expect to see within the Office slicer, once you select an LWDB/WDA, and then go to select an Office. Those offices won't go away until all <u>historical data</u>, portrayed on our WPC <u>Department of Labor (DOL) reports</u> dashboards, has elapsed (Currently, 6 quarters need to elapse) (See example in Section B.3 below).
 - FYI The DI team has <u>not found</u> any significant data in any of those offices. There is just a count of one or two job seekers, here and there.

 - The PIRL report captures activities and performance within the Workforce (WorkSource) system. It is the tool, of which states use to communicate such activities and outcomes to the Department of Labor (DOL) Employment and Training Administration (DOLETA or ETA for short).
 - The PIRL supports all of the DOL PMs and QRAs, and their accountability, for the entire WorkSource System.
 - And therefore, the PIRL supports the funding, for the entire WorkSource System.
- PMs Performance Measures (PMs)
 - The Department of Labor (DOL) describes why it is so important to report performance:
 - "The public workforce development system provides resources, services, and tools to support individuals and businesses in developing and maintaining a workforce to support a thriving economy throughout the nation. Given the critical importance of this system, its performance at the local, state, and federal levels is vitally important. Consistent, accurate performance reporting the workforce system to assess its effectiveness, make data-informed improvements, be accountable to taxpayers, and, ultimately, support vibrant communities, businesses, and families throughout the nation."

- PY24Q3 Program Year (PY) 2024 (July 2024 June 2025), for Quarter 3 (Q3) (January 1, 2025 March 31, 2025).
- **QPRs** <u>Quarterly Performance Reports</u> (QPRs) are designed, defined, and maintained by DOL, within DOL's QPR Specifications (<u>QPRs (ETA- 9173) OMB Control Number 1205-0521 (Expiration Date: 03-31-2027)</u>.
- **QRA** <u>Quarterly Reporting Analysis</u> (QRAs) (aka, by DOL, as the PIRL Data Integrity (DI) Reports)
 - The DOL QRAs are not currently outlined in DOL official guidance (TEGLs, TENs), and are currently only in a "pilot" stage, by DOL, for some of the states. WA state is not in a "pilot" state, and we are only currently being <u>monitored</u>, by DOL, for the QRAs. But the DI team has been verbally told by DOL, in an official DOL national ZOOM call, that DOL is on the horizon for laying out all of the DOL QRAs, in official DOL guidance (TEGLs, TENs).
 - The DI team is not clear on whether the QRAs will only be held accountable, by DOL, at the statewide level, once DOL official guidance (TEGLs, TENs) is published.

- TAADI Trade Adjustment Assistance Data Integrity (TAADI) reports
